## What is A Designated Fund?

A designated fund is a special fund established through the EFCA Foundation to support one or more ministries of the Evangelical Free Church of America. This helps one or more ministries meet their mission now and in the future, or provide sustaining income to EFCA ministries that matter.

### How it works:

- Name the fund.
- Set the payout percentage that would go to your designated ministries.
- Give assets such as cash, appreciated stock or approved real estate.
- Secure an immediate charitable deduction.
- Opportunity to later add to the fund through current giving, bequests, or through beneficiary designations on IRAs, retirement accounts, or investment accounts.

# WHICH EFCA OR RELATED MINISTRIES CAN BE NAMED?

**Short Answer:** Almost all.

Consider the following EFCA Ministries:

**Local:** Nearly 1500 Local Churches and Church Plants

**Regional:** 17 District Ministries

**National:** Office of the President, EFCA ReachNational

**International:** EFCA ReachGlobal and over 600 missionaries

- 1** Complete an agreement:
  - Name fund
  - Set purpose
  - Designate ministry or ministries
  - Determine payout percentage
  - Date and sign
- 2** Return the agreement.
- 3** Once the account has been funded (initial gift of \$5,000 or more) we will send you an approved copy for your files.
